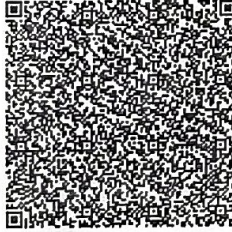

20. The School has gone through the contents of books prescribed.

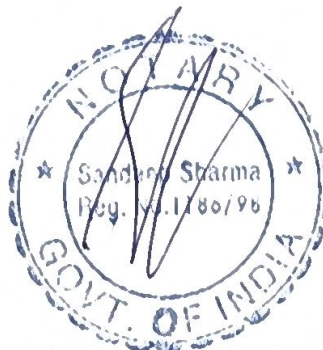
